

Held every January, the Allied Social Science Associations (ASSA) meeting provides exhibitors access to over 13,000 economists and scholars in related disciplines. Due to the continued uncertainties related to the potential spread of COVID-19, the 2022 ASSA Annual Meeting will be held as a virtual event. The meeting will take place on January 7-9, 2022, which is a Friday, Saturday, and Sunday. The AEA leadership believes that, despite the departure from normal circumstances, we will have an engaging and successful 2022 meeting.

Virtual Exhibit Space: Take advantage of this excellent opportunity to present new products and reach your customer base through an online presence at the 2022 ASSA Virtual Meeting.

The cost for virtual exhibit space is \$750 and includes the following:

- ATIV platform:
 - Your logo displayed on the exhibit page.
 - A brief description of your organization.
 - Five links that can be used for PDFs, website pages, videos, calendar scheduling, links to your own website where zoom meetings may occur, etc.

- Three one-hour Remo events. One event will take place each day, Jan 7-9, from 2:30-3:30pm ET:
 - Video chat with fellow attendees through the REMO virtual event platform. Dedicated virtual tables for exhibitors will allow participants to learn about new and revised products.
 - Participants can move between virtual tables to join conversations and network.

- An ASSA Event listed on the ASSA event program in a dedicated timeslot (TBD) for exhibitors. **Exhibitor must send a request to**

gwyn.p.loftis@vanderbilt.edu after booth purchase to be included in this event. Presentations will be approx. 3-5 minutes, depending on the number of exhibitor requests and the length of the event. Number of exhibitors who can participate in this event may be limited due to time constraints.

- Four complimentary meeting registrations, which will allow access to sessions and events from a desktop browser or the event app on a mobile device. The virtual platform allows you to build a personal daily schedule, receive reminders and updates, search the program, take notes, and more. The app will become available for download in the first week of December.
