New Pricing Structure for AEA Journal Subscriptions

The Association has moved to a two-tier pricing structure with price increases phased in from 2022 to 2024. This two-tier pricing structure is based on our findings that R1-designated universities download significantly more articles than others.

Accordingly, Tier 1 pricing will apply to organizations identified as R1 universities by the Carnegie Classification of Institutions of Higher Education, as well as international universities included in the top 200 of the Shanghai Academic Ranking of World Universities. Tier 2 pricing will apply to all other institutions.
